



Annual Report

CO-CHAIRS' LETTER





Dear Friends,

We thank you for your support and dedication to furthering JBI's mission of inclusion and accessibility. With your help, JBI is ensuring that individuals who are blind, have low vision, or are print disabled are connected with Jewish education, culture, and heritage, and fully able to participate in their communities.

One of the actions we are most excited to highlight from 2023 is our new strategic plan. With this new roadmap, we are set to grow, evolve, and better connect to our current patrons and expand our outreach to many who do not yet access our services. Our new strategic initiatives will broaden and enhance our services, further foster a feeling of connection to our community, encourage learning, and ensure inclusion. These goals are all the more relevant in the wake of October 7th, which has reinforced the importance of our mission and the need to remove all barriers to access to Jewish life and its rich heritage.

Key elements of our new strategic plan include:

1. Increasing the number of books and texts available, and the formats in which they're offered

We are expanding our library's selection of high-quality braille, large print, and audio content, including fiction, nonfiction, young adult reads, and books for children and families to enjoy together, as well as liturgical offerings. We are also continuing our efforts to expand digital options, and increase accessibility for those with a physical disability, dyslexia, or other reading disabilities.

2. Offering new and engaging programming

We are focusing on new live and virtual programs to give patrons additional opportunities to engage with JBI, with one another, and the Jewish community, through our accessible materials. These include virtual book clubs, text study sessions, language classes, and author readings. Our new Patrons' Council provides an outlet for members to share valuable input and shape such programming.

3. Upgrading our technologies

It is critical that our patrons have quick and easy access to the information and texts they need, in the formats they prefer. We are investing in new up-to-date systems to improve accessibility, including a new website, online library, and improved technologies for digital, on-demand materials.

4. Championing increased inclusion and accessibility, especially within the Jewish community

We are partnering with schools, camps, synagogues, museums, libraries, social service organizations, and retirement homes across the country to encourage the creation and promotion of content further enabling engagement in Jewish life. Thanks to a grant awarded by the New York Community Trust, we are able to provide large print, braille and audio materials to the patrons of organizations across NYC for the next two years free of charge.

Going forward, we will continue to strengthen these and other programs, all of which deepen JBI's ability to deliver meaningful services to our patrons, from older adults seeking literature for enjoyment, to students pursuing a Jewish education, to anyone wishing to access their religious practice. For many with visual impairments who might otherwise feel isolated, JBI's collection of books, periodicals, religious texts, and cultural programs are a crucial link to Jewish life and culture.

It is only due to your ongoing support that we have the ability and resources to undertake these new initiatives and efforts, which are more important today than ever. We thank you for your passionate commitment to bringing us together to access—and celebrate—Jewish life and culture.

EXECUTIVE DIRECTOR'S LETTER



Dear Friends,

In an ever-increasingly complex world, finding ways to create belonging and community and develop a deeper understanding of and engagement with Judaism—in all its facets is challenging. But this year has proven to me that JBI is inspired and ready to take this

important work on. I am extremely proud of what JBI's board and staff have done to explore and implement creative ways to advance our core mission of making the Jewish world accessible to everyone who has vision impairment of any kind.

At the same time, JBI continues to be responsive to the needs of its patrons, developing important audio, braille, and large print materials of Jewish interest— many of which are often simply not available anywhere else. And we're simultaneously forging new paths to patrons through enhanced technology, diverse partnerships with organizations whose missions overlap with ours, and amplification of our work across media and social media to reach growing audiences.

This year we have also come to embrace the critical role we can play in building and strengthening access to the Jewish community in multiple ways. We are expanding new in-person and virtual programs, such as book groups, poetry workshops, Patrons' Council meetings, lectures, and special events, and introducing a new hybrid Judaism 101 series this fall.

I have also had the privilege of attending conferences of the blind, meeting people from vision impairment service organizations around the country, and working closely with patrons and others with disabilities, and the message I've come to understand is very clear. Creating barrier-free access does not mean waiting until someone asks for assistance, but rather ensuring that individuals with accessibility needs never have to ask to feel fully welcomed, encouraged, dignified, and included in our community. To this end, JBI is actively collaborating with other organizations like synagogues, museums, social service providers, and cultural groups on inclusion initiatives and serving as accessibility consultants to others seeking to instill accessibility and inclusion as a core value and build it into their organizational culture, capabilities, and offerings.

We at JBI consider all of this work to be a moral imperative, and we are proactive and passionate about making inclusion a reality for everyone. True inclusion requires intentional efforts to accommodate the needs of all members of our community and ensuring that anyone who seeks to learn more about Jewish life, culture, ritual, and community can do so easily. JBI believes there should never be barriers to engagement with our stories and sacred texts. Leviticus notes that we must not "put a stumbling block before the blind." And while the verse is usually applied metaphorically, here at JBI we are mindful of its literal meaning as well. Inclusion aligns with our core values of justice, compassion, and love for all, and enables us to fully engage as Jews.

And for all the work we've accomplished, I truly believe that we can look forward to even more positive impact as we continue to implement technology updates currently underway, nurture our partnerships, diversify and update our materials, and create more new programming. Whether you are a longtime patron or someone just learning about JBI, we are here to serve as a place where anyone with visual impairment or print disability can come to gain barrier-free access to Jewish community and Judaism.

2023 Highlights

- We launched a new strategic plan focused on providing even better services to our patrons through increased programming, broader offerings and new technologies.
- We engaged new patrons through our ever-increasing circulating library, liturgical, and lifecycle materials, customized offerings, and cultural programming.
- We are now serving approximately 12,000 individuals directly, plus many more indirectly through our work with collaborating organizations.
- We circulated 14,000 audiobooks.

- We increased our communication with patrons through more frequent newsletters (braille, large print, and email) and we established our JBI Patrons' Council to share news and opportunities, build community, and solicit patrons' input and feedback.
- We produced and distributed 4,800 large print and braille liturgical and lifecycle materials, including our braille and large print *luach*.
- We regularly produced and distributed audio magazines and cultural programs for more than 1,000 magazine readers.

- We expanded our capacity to help partnering organizations produce braille, large print, and audio materials to make their programming and communities more accessible for people with visual impairment.
- We grew JBI's social media presence significantly through increased activity and engagement on Facebook and LinkedIn, and a new Instagram account. We are leveraging these platforms to reach new audiences and keep our patrons and partners informed.
- We added new audio and braille titles to our circulating library, childrens books in multiple accessible formats, and new editions of liturgical offerings

including three new *Haggadot*, a PJ Library High Holy Days guide, *Selichot*, and more.

- We broadened our collaborations with more than 200 organizations that serve people with visual impairments and Jewish social service organizations. A few examples: PJ Library, Jewish Book Council, Matan, JASA, Xavier Society for the Blind, CSB Cares, Visions, Vision Services Alliance, DOROT, and the National Library Services of the Library of Congress.
- We awarded four exceptional college and graduate students with Nathan L. and Suzanne K. Wolfson Scholarships totaling \$60,000.


